ARTICLES OF ORGANIZATION

FIRST: The undersigned, Daniel Joseph White, whose address is 40415 Breton View Drive, Leonardtown, Maryland 20650, being at least eighteen (18) years of age, having been duly authorized to execute and file these Articles of Organization by the members of the limited liability company named herein, hereby form a limited liability company under and by virtue of the Maryland Limited Liability Company Act and the General Laws of the State of Maryland.

SECOND: The name of the limited liability company (which is hereinafter referred to as the "company") is:

LEONARDTOWN INVESTMENTS, L.L.C.

THIRD: The purposes for which the company is formed are as follows:

- a to own and operate an investment company; and
- b to engage in any lawful act or activities permitted by a limited liability company organized under the laws of the State of Maryland.

Nothing herein contained shall be deemed to authorize or permit the Company to carry on any business or exercise any power or do any act which a limited liability company formed under the laws of the State of Maryland may not at the time lawfully carry on or do.
