The event occurred on 03/26/2023 at approximately 02:00 at 1300-1399 BLOCK H STREET NE, 13TH STREET NE & 14TH STREET NE, WASHINGTON, DC 20002.

On March 25, 2023 members of the Metropolitan Police Department responded to the 1300 block of H Street NE Washington DC in reference to an individual stabbed. Once on scene, members conducted a preliminary investigation and determined the event was a bona fide stabbing. A First District Detective was requested and Detectives Gong and Barrows responded to the 1300 block of H Street NE Washington DC.

Detective Gong's investigation:

When Detective Gong arrived on scene, the first thing observed was a silver knife that was laying on the sidewalk in front of 1305 H Street NE, on the curb close to the street drops of blood was discovered. Further down the block near 1513 H Street NE Washington DC, bloody clothes (later identified as Complainant Todd's clothes) were found on the ground.

Detective Gong interviewed Complainant Barnard who stated he and his friend (Complainant Todd) was walking from another restaurant when Suspect-1 jumped at them from behind a wall. Complainant Barnard stated Complainant Todd was closer to Suspect-1 and Suspect-1 jumped on top of Complainant Todd and did a stabbing motion to Complainant Todd's head.

Detective Gong spoke with two witnesses in regards to this case; Witness-1 who stated the following, IT was in the 1300 block of H Street NE when IT saw Suspect-1 make a punching motion to the face of Victim-1.

Witness-2 stated IT was walking east from another restaurant when IT saw Complainant Todd on top of Suspect-1 and Complainant Barnard yelling, 'Phil (Complainant Todd) got stabbed!'

Detective Greene's interview with Complainant Todd at the hospital:

Complainant Todd was conscious and able to speak with Detective Greene. Complainant Todd does not know Suspect-1 and has no idea why Suspect-1 attacked him. Complainant Todd stated that Suspect-1 did not demand anything nor say anything to Complainant Todd prior to the attack.

Complainant Todd could not provide a description of Suspect-1 and could only state that he recalled seeing a knife in Suspect-1's right hand. Complainant Todd stated that he was attacked after exiting Sol Mexican Grill with his friend, Complainant Barnard.

Additionally Detective Greene learned of Complainant Todd's injuries:

A laceration to the left ear that may require reconstruction.

A puncture wound to the left side of his head, which penetrated the skull and likely caused an internal brain bleed.

A puncture/laceration to the lower left torso that was deep in nature causing Complainant Todd's left lung to be punctured.

A minor puncture wound to the left chest.

Complainant Todd will be undergoing an initial surgery concerning the punctured lung and potential internal bleeding.

Complainant Todd will later undergo a second surgery concerning his potential brain bleed after neurological consultation.

At the time of this writing, Complainant Todd's current condition is considered Critical-Guarded-Stable pending further surgery.

Video footage review:

Video footage was recovered from 1301 H Street NE Washington DC (The Lucille), the video footage shows the following:

Complainant Todd (wearing a khaki colored coat) and Complainant Todd (wearing a dark colored jacket) are seen walking eastbound in the 1300 block of H Street NE Washington DC side by side. At 17:17 hours (5:17 PM) Complainant Todd is seen taking a hard fall onto the ground.

As Complainant Todd fell to the ground, Suspect-1 is seen jumping on top of Complainant Todd. Suspect-1 and Complainant Todd are seen in a struggle with Suspect-1 on top of Complainant Todd for approximately six (6) seconds.

Complainant Barnard pushes Suspect-1 off of Complainant Todd and the two are seen running eastbound in the 1300 block of H Street NE. Suspect-1 casually stands up and walks away west in the 1300 block of H Street NE.

In this video, Suspect-1 is observed to be wearing a navy colored jacket, Nike hoodie underneath the jacket (Nike logo on the left chest), dark blue jeans, and grey, black, and red sneakers.

Video from 1305 H Street NE Washington DC (Noble Tobacco Cigar and Vape) was recovered as well, which shows the following (note: the time stamp on the video is one (1) hour behind real time):

At approximately 04:17 PM (05:17 PM real time) Complainant Todd and Complainant Barnard are seen walking east in the 1300 block of H Street NE.

As the two are walking Complainant Todd falls to the ground and Suspect-1 is seen getting on top of Complainant Todd making punching motions at the upper area of Complainant Todd's body.

Complainant Barnard pushes Suspect-1 off of Complainant Todd and the two Complainants escape eastbound in the 1300 block of H Street NE.

Suspect-1 stands up from the ground and a silver object (later discovered to be a knife) was found under Suspect-1. Suspect-1 then walks off camera, west bound in the 1300 block of H Street NE.

Suspect identification:

While on scene in the 1300 block of H Street NE Washington DC. Detective Gong was advised by Officers on scene that there were two (2) cellphones recovered on scene and both were taken with Complainant Todd to the hospital.

Further investigation revealed that one of the cellphones was confirmed to be Complainant Todd's, however, there was one other unidentified cellphone that had blood smeared on it.

Based on this random violent attack and the seriousness of the injuries sustained by Complainant Todd, Detectives determined it was exigent to identify the owner of the cellphone due to it reasonably being Suspect-1's cellphone.

Based on the exigency of the situation, Detectives were able to obtain subscriber information and an individual to call. The individual was learned to be a Ms. Yolanda Neal.

Detective Greene called Ms. Yolanda Neal and learned that the recovered cellphone was given to an individual by the name of 'Glynn Neal' by Ms. Yolanda Neal.

Through the Detective's investigation, it was learned Mr. Glynn Neal currently resided at 2656 Sheridan Road SE Washington DC with his sister, Ms. Yolanda Neal.

On March 26, 2023 Detectives Gong and Barrows conducted a follow up at 2656 Sheridan Road SE Washington DC with Ms. Yolanda Neal.

Detective Barrows inquired about the clothing Mr. Glynn Neal was last seen wearing, Ms. Yolanda Neal described Mr. Glynn Neal to be wearing a black long sleeve Nike shirt with the Nike logo on the left chest, blue jeans, and black, red, grey Jordans.

During the interview, there was a door knock in the rear of the home. Ms. Yolanda Neal went to go open the door and an individual is observed by Detectives and Officer Hsu wearing the same outfit as Suspect-1.

The individual who came down the stairs was identified as Mr. Glynn Neal. Observed on Mr. Glynn Neal's right pinky and upper right lip were injuries that appeared to have been caused recently.

Based on the fact Mr. Glynn Neal wearing the outfit of Suspect-1 as observed on the video footage recovered, probable cause was developed to arrest Mr. Glynn Neal.

Mr. Glynn Neal was subsequently placed under arrest and transported to the First District for booking. Mr. Glynn Neal will hereinafter be referred to as Defendant Neal, DOB: January 18, 1981.

Custodial interview with Defendant Neal:

On March 26, 2023 Detectives Gong and Barrows conducted an interview with Defendant Neal. Detective Gong read Defendant Neal his Miranda Rights to which Defendant Neal waived.

Detective Gong asked Defendant Neal what he did today. Defendant Neal replied with words to the effect of, 'A voice was telling him that someone was going to get him for all the things he done. So he [Defendant Neal] was waiting right there to get the someone.'

Detective Gong asked if Defendant Neal remembered being dropped off at 12th and Florida NE. Defendant Neal agreed that he did.

During the interview, Defendant Neal stated he wanted to talk to a lawyer and the interview was subsequently ended.

The event and acts described above occurred primarily in the District of Columbia and were committed as described by defendant(s) listed in the case caption.
