HONORABLE JUDGE SALERNO,

YOUR HONOR, I WAS SIX TEEN YEARS OLD, AND  
WAS ARRESTED FOR ARMED ROBBERY WITH A  
HAND GUN, ON JUNE-28-2017, AND SENTENCED  
TO SERVE 60 MONTHS. ON APRIL 5, 2017, ARRESTED  
FOR CARRYING AMMUNITION. ON JUNE 28, 2017 ARRESTED  
FOR CARRYING A PISTAL WITHOUT A LICENSE, AND  
POSSESSION OF AN UNREGISTERED FIREARM, CONVICTED  
ON MAY 6, 2010, AND WAS SENTENCED TO THREE  
YEARS SUPERVISED PROBATION. HONORABLE  
JUDGE SALERNO, THREE YEARS IN PRISON HAS  
TAUGHT ME CRIME IS NOT WORTH IMPRISONMENT  
HONORABLE JUDGE SALERNO, I AM 19 TEEN YEARS  
OLD, AND HAVE CLEAR CONDUCT FOR 3 YEARS, AND  
NO INCIDENT REPORT AGAINST MY INCORPORATION  
AND DIE TO MANY PRISONERS DYING OF CORONA-19  
VTRUS, ALL PRISONERS BEEN LOCKED IN OUR CELLS...

5 MONTHS, 22 HOURS A DAY, SEVEN DAYS A WEEK FOR EXTRA PROTECTION WHICH HAS EXTREMELY HARDSHIP CONDITION, AND STAFF HAS CUT OUR NORMALE FOOD SUPPLY IN HALF DUE, TO LACK OF FOOD SUPPLY, DUE TO Covid-19 - Virus...

JUDGE SALERNO, I AM NOT ELIGIBLE FOR COMPASSIONATE RELEASE, OR ANY OTHER ACT IN FEDERAL SYSTEM, BECAUSE I AM DISTRICT OF COLUMBIA PRISONER. UNDER FEDERAL LAW, I CAN NOT EARN GOOD TIME CREDIT AS OTHER DISTRICT PRISONERS HOUSED IN STATE PRISON, AND SUBJECTED TO INCREASED TIME UNDER FEDERAL RULES. I HAVE 7 MONTHS TO SERVE. PRISONS IS VERY UNSAFE, OVER CROWD AND VERY DANGEROUS. I DO NOT WANT TO DIE FROM Covid-19, MERSA OR THE NEW YORK VIRUS WITH NO CARE.

HONORABLE JUDGE SALERNO, I AM A SLOW LEARN AND I AM SORRY FOR MY BEHAVIOR I WAS ASKED 4 YEAR HONOR PLEASE GIVE ME TIME SERVED UNDER RULE 85(B) OR ANY OTHER RULE I WILL AGREE TO WEAR LEG MONITOR FOR 9 MONTHS AND ANY OTHER CONDITIONS THE COURT HAS TO BE SAFER.

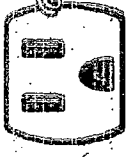

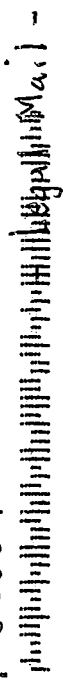
