SUBJECT: Annual Audit of Property and Evidence

Sheriff Timothy K. Cameron has designated me to conduct the annual audit of the Sheriff's Office property and evidence areas.

On May 29, 2014, I conducted an audit of the Sheriff's Office property and evidence areas to ensure the continuity of custody of property and evidence. The annual audit was completed pursuant to Commission on Accreditation of Law Enforcement Agencies (CALEA) standards 84.1.6 (bullet c). The locations audited were [REDACTED]

I found all the property areas were neat, clean and well organized. Evidence was packaged, labeled and organized by year and case numbers. Drugs, money and weapons were separated and secured in locked rooms, cabinet and/or safe.

I observed all guns were properly stored in the gun room and no guns were stored in the regular property storage area. The weapons storage room was clean and well organized, but contained several hundred weapons stored in the small room. The weapons storage area is not adequate to store the quantity of weapons seized and/or stored by the Sheriff's Office. Although, there is a large volume of weapons in storage it must be noted the Property Specialists were able to locate all items audited quickly.


The audit included the review of the property record and the retrieval of the property. See the attached documents of the property audited.
