SUBJECT: 2015 Annual Announced Property and Evidence Audit

On May 11, 2015, I conducted an annual announced audit of Sheriff's Office property and evidence areas to ensure property and evidence in the custody of the Sheriff's Office was properly accounted for and all related documents were available. This audit was conducted pursuant to the Commission on Accreditation of Law Enforcement Agencies (CALESA standards 84.1.6. The locations audited were [REDACTED].

All property areas were neat, clean and well organized. Evidence was labeled and organized by year and case numbers. All evidence packages, selected for inspection, contained bar coding labels and were properly sealed utilizing evidence labels with the exception of firearms. Controlled Dangerous Substances, currency and weapons were separated and secured in locked rooms, cabinet and/or safes.

Firearms were stored in a secured room which is only accessible by authorized personnel within the agency. The room is extremely crowded which inhibits an orderly system for storing of firearms. The room is extremely inadequate for the storage of the quantity of weapons being held / seized by the Sheriff's Office. I would estimate there are over 1,000 firearms contained in the room. Remarkably, property personnel were able to retrieve each firearm requested for the audit with little effort and very quickly.

[REDACTED] During the audit of property under Case Number 17398-10, [REDACTED], all property was properly accounted for. However, documents related to the property could be located by the property custodians. This was the single discrepancy found among the items audited from all locations.

The audit included the random selection of a case number and requesting presentation of the correct property and all documents related to the storage of the selected property. The need for additional space for storage of property remains a critical and major concern. The room containing firearms has practically reached its capacity.

Mr. Charles Farreri and Mr. Darryl Greb are to be commended for their attention to detail and their outstanding performance of duty pertaining to the storage of an enormous and ever increasing amount of property and evidence being maintained within a limited amount of space.
